- 5. **Reviewed Status of Violations**: Currently we have 5 violations outstanding. Compliance on violations issued has been positive. To date we have not had to impose fines.
- 6. **Developed plans for Newsletter**: We will purchase a weather proof holder to be Mounted on the fence near the entrance. Plan to begin a monthly newsletter in April. - 10. **Playground equipment**: repair or replacement? Voted that the current wood structure is in unsalvageable condition and is a safety hazard to children. Kristine is researching a durable replacement, possibly a swing set. Whatever we find must fit in the current footprint.
- 11. **Gate**: Discussed the situation regarding the lack of power to the parking lot gate. There are remotes that should operate it. Currently there is no electricity running to it. Jim will get estimates to repair it. LOW PRIORITY ITEM
- 12. **Pool**: Repair has been completed and the pool is open.
- 13. **Ball Team Request**: Discussed a request we received to host an organized neighborhood ball team. Due to legal liability, we do not believe we should do it. We do, however, encourage residents only play.

- 14. **Social Event**: We will be asking the Social Committee to plan a Memorial Day Event.
