Projects currently in the works are the repainting and surfacing of the deck surrounding the Community Pool. The color will remain the same. The current paint is chipped and peeling. We will be working to get this completed before we hit the high season of use for the pool. As a result, the pool will be closed for a few days to let the surface dry.



In addition, we will be working on touching up the black fence surrounding the park and particularly the parking lot area.

Repairs/replacement are also being made to the electronic gate to the parking area. This has not functioned for several years and needs to be opened and closed manually each day.

We are also currently working on replacing the piece of playground equipment which had to be removed for liability and safety concerns.



UNPAID HOA DUES!

We currently have approximately 22 owners who have not paid their 2019 HOA Dues! Please note that a LIEN will be placed on any property with unpaid dues on April 15, 2019. Last year the average cost to remove a lien was approximately \$1400.00. These liens are handled by the attorney with no cost to the Association. SAVE YOURSELF SOME \$! Pay your dues!

- Swim at your risk! No lifeguard on duty!
- Residents are responsible for supervision of your children under the age of 14 at ALL TIMES!

- Appropriate swimsuits only! Babies must wear "Swimmies"!
- No alcoholic beverages permitted!
- Please shower before entering the pool.
- No pets, skateboards, bicycles, or similar equipment in the pool area.
 We have a bike rack!
- No diving, running or horseplay permitted!
