notifying that you have a HOA Violation. It will indicate the

amount of time you have to correct the issue before a Violation is issued. **IF** the violation is not corrected within the allotted time, **OR** you have a repeated violation, you will receive **ONE** 

#### **VIOLATION NOTICE**

(printed in red ink) indicating that you will be receiving a Violation in the mail. This letter will indicate the date the fine will begin to be assessed and the daily amount of the fine. When unpaid fines reach \$1,000 a lien will be placed on your property.

Violating neighbors is something no one enjoys, but it must be done to preserve the home values in our community. Please prevent receiving a violation by following the HOA rules.

### **POOL & PARK**

There has been a lot of activity going on in the pool and park over the last couple of months.

#### **POOL**

The community swimming pool has been resurfaced and new non-slip tiles installed. This tile replacement kept the pool closed for several months as we were waiting for permits from Osceola County. During the COVID shut down, their offices were stalled along with the rest of us. The replacement was mandated by the County Health Department and were not an optional installation. This was an expensive project but one that was necessary to keep the pool up to code.

#### **PARK**

The park was closed for a period of time due to County mandates related to COVID 19. The park is open again for recreational use. The basketball hoops have been temporarily removed. There was a test opening of the park and the first day there were 20 kids/teens playing basketball in close contact. The decision was made that in order to open the park safely, the best option was to remove the hoops to prevent clusters of individuals in close proximity to each other.
